



## COVID-19 Greenwood Campground Regulations and Waiver

### Regulations

The following regulations shall apply for the opening of the Town of Sundre Greenwood Campground and remain in place until further notice, with updates to be provided and coordinated with AHS guidance at all times:

1. No transactions will be allowed in cash; only Debit, Mastercard, and Visa will be accepted.
2. Person signing this document is responsible for ensuring that all overnight guests of the campsite are aware of the COVID-19 protocols posted and listed in this document.
3. Persons displaying any symptoms of illness will not be permitted to stay overnight or access the Campground.
4. Washrooms/shower house and Cookhouse shelter shall remain closed.
5. Only self-contained RV units will be allowed. You may be asked to provide proof that the washroom facilities within the RV are adequate.
6. Means of social distancing, as outlined by AHS requirements, must be maintained, unless from same household or cohort family.
7. No unregistered guests allowed to your campsite.
8. Sanitize contact surfaces before and after use at Potable Water fill and Sani-Station. Bringing alcohol-based sanitizer is recommended for hand hygiene when soap and water are not available. You are to provide your own PPE (gloves, masks, etc.) as needed for utilizing the Campground.
9. Picnic Tables, use a cloth/cover on the table.
10. Dispose of trash in receptacles provided or take it with you to reduce risk for staff and other users.
11. Camp Host will maintain 2m (6ft) physical distancing when performing check in rounds.

### Waiver

Use of the Campground is at your own risk: use of the Campground is voluntary and is not deemed a necessity or essential service. Your use of the Campground shall waive all liability and/or legal responsibility held by the Campground, either directly or indirectly associated with damage, illness (including contraction of COVID-19) or injury resulting from use thereof. Proper conduct, self-guidance and adherence to AHS guidelines is strongly encouraged at all times.
